### AIRPORT IMPROVEMENT PROGRAM PROJECTS

<u>AIP-62 (Terminal/Station 1 HVAC, Roof Replacement)</u> – CWG Architects has submitted claims for some completed work on the two projects to replace the roof and HVAC components. We recommend approval of the claim as submitted.

We are excited to see the HVAC component replacement project begin this coming spring/summer. We continue to struggle keeping some of the existing units operating, but our staff keeps finding ways to keep units running.
